The Works will be carried out under Serbian Law and FIDIC Yellow Book Conditions of Contract for Plant and Design-Build, First Edition, 1999 and will include: civil and architectural works, electro-hydraulic drive upgrade works, hydro-mechanical equipment upgrade works and upgrade works to the ancillary systems of the lock.
