Question No 1 Can the forms given in Volume 1, Section 4 be filled by hand?	Answer No 1 Manner of filling in the forms is solely responsibility of a tenderer. Volume 1, Section 1: Instructions to Tenderers - Clause 11 "Content and Presentation of Tender" and Clause 12 "Information/Documents to be supplied by the Tenderer" give content, conditions; list of forms, documents and information from which a Tender must be comprised.
<b>Question No 2</b> Is it possible to issue Tender Guarantee according to percentage of occupation by members of JV? For example, we're going to form a JV with partner A and partner A's percentage will be 40%. Is it acceptable to provide 2 Tender Guarantees in amount of EUR 660,000.00 and EUR 440,000.00? The total amount will be EUR 1,100,000.00.	Answer No 2 No. All members of joint venture/consortium are considered <b>a tenderer</b> that shall submit one tender as instructed in Volume 1, Section 1: Instruction to Tenderers Clause 4. "Only one tender per tenderer". According to Volume 1; Section 1: Instructions to Tenderers Clause 15.1 quote: "The tenderer must provide, as a part of its tender, <b>a tender guarantee</b> in the form set out in Volume1, Section 3 of the Tender Dossier" end of quote. Kindly note that the above-mentioned form has instructions in case a
